

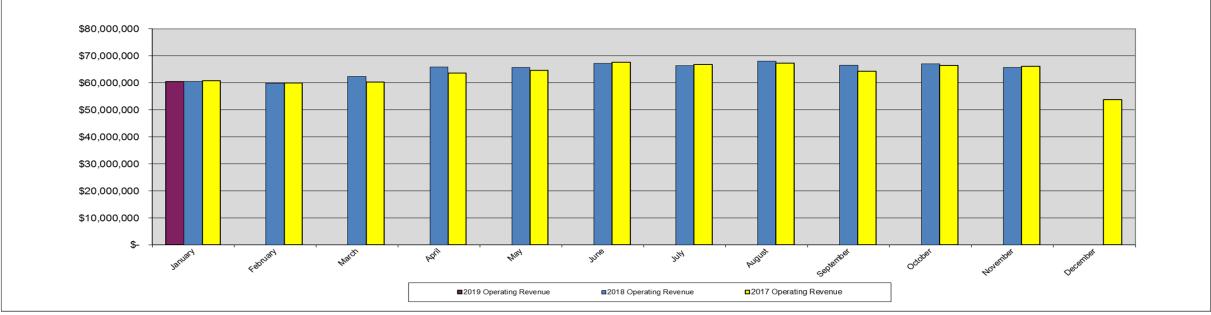

Total Revenue

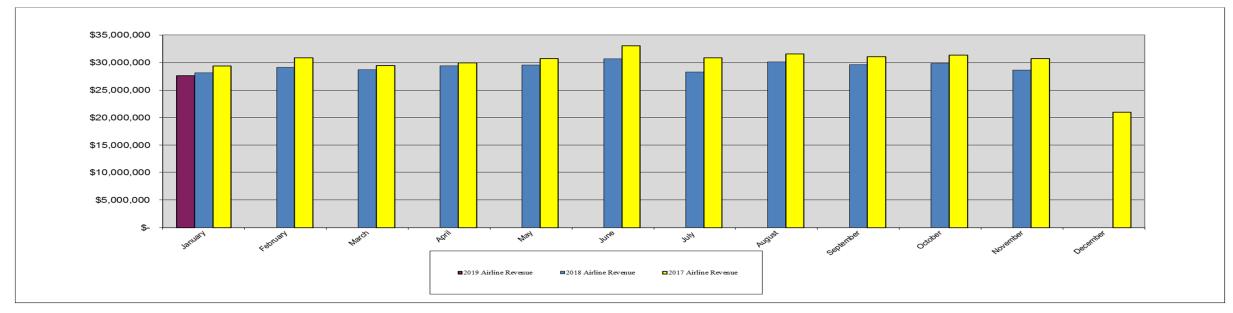
- Total Revenue thru January 2019 is \$60.5 million

<u>Airline Revenue</u>

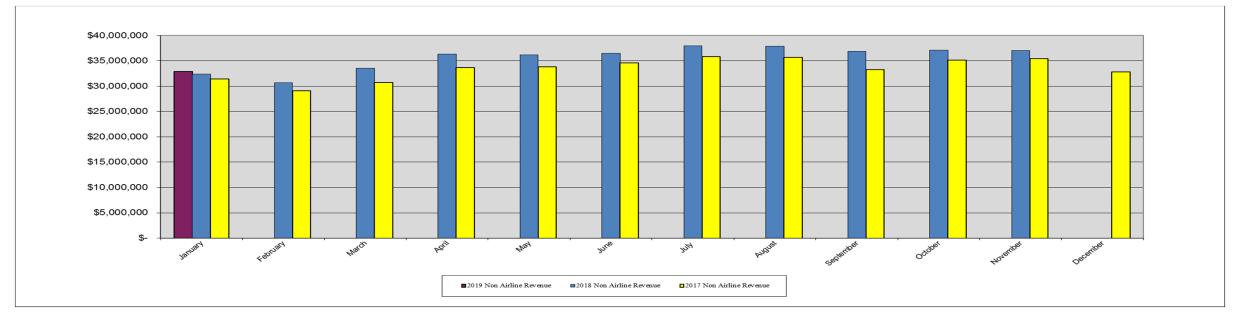
- Airline Revenue thru January 2019 is \$27.6 million

Metropolitan Washington Airports Authority Financial Statements January 2019 Aviation Enterprise Fund – Highlights in Brief

- ✤ Total operating revenues for the Aviation Enterprise Fund for January 2019 were \$60.5 million. Operating revenues increased from December 2018 by \$9.5 million mostly due to increases in landing fees of \$6.9 million, international arrival fees of \$1.3 million, passenger conveyance fees of \$1.1 million, rents of \$0.6 million and utility sales of \$0.1 million offset by a decrease in concessions of \$0.6 million.
- ✤ Operating revenues of \$60.5 million in January 2019 were about the same as 2018 totals. Concessions increased by \$0.6 million offset by decreases in rents of \$0.3 million, international arrival fees of \$0.1 million and landing fees of \$0.1 million.
- ✤ Total operating expenses for the Aviation Enterprise Fund during the month of January 2019 were \$58.9 million, which is \$2.4 million lower than December 2018 mostly due to decreases in project expenses of \$4.4 million, depreciation and amortization of \$2.9 million, services of \$2.6 million and telecommunications of \$0.2 million offset by increases in salaries and related benefits of \$5.8 million, materials and supplies of \$1.6 million, utilities of \$0.3 million and insurance of \$0.1 million.
- → Operating expenses of \$58.9 million in January 2019 were \$8.7 million higher than 2018 primarily due to increases in services of \$3.1 million, salaries and related benefits of \$3.1 million, materials and supplies of \$1.7 million, depreciation and amortization of \$0.3 million, utilities of \$0.2 million, telecommunications of \$0.2 million, and insurance of \$0.1 million.
- → Operating income for the Aviation Enterprise Fund in January 2019 was \$1.6 million compared to operating loss of \$10.2 million in December 2018. Operating income in January 2019 was \$1.6 million, \$8.7 million less than January 2018.

- In January 2019 there were net non-operating expenses of \$13.9 million compared to net non-operating expenses in December 2018 of \$41.8 million resulting in a change of \$27.9 million primarily due to decreases in interest expense of \$28.9 million and fair value loss on swaps of \$4.1 million offset by decreases in other gains of \$2.5 million, federal, state, and local grants of \$2.2 million and investment gain of \$0.5 million. Net non-operating revenues in January 2018 were \$5.7 million.
- → The net capital contributions for the Aviation Enterprise Fund for the month of January 2019 were \$6.3 million compared to \$3.6 million in December 2018. The \$2.7 million increase is due to a decrease in net contributions to other governments of \$4.4 million and an increase in passenger facility charges of \$1.9 million, offset by a decrease in federal, state and local grants of \$3.5 million.
- → There is a decrease in net position for the Aviation Enterprise Fund for the month of January 2019 of \$5.9 million compared to a decrease of \$48.4 million for the prior month. Net position in January 2018 was an increase of \$21.4 million.
- → Debt service coverage decreased from 1.81x from December 2018 to 1.54x for January 2019.

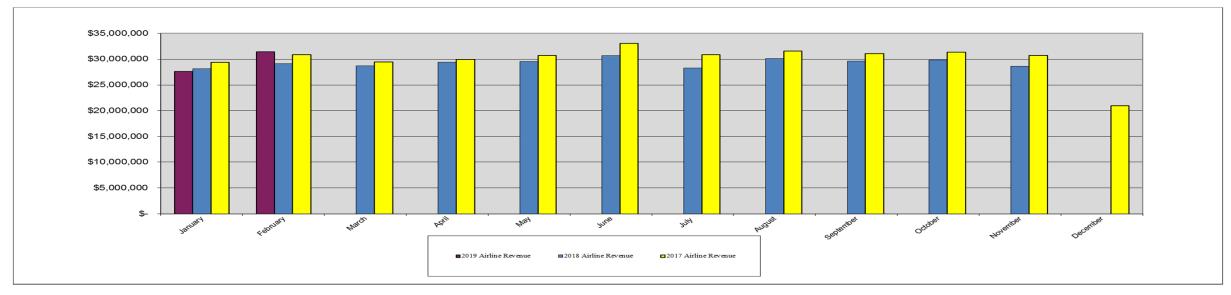

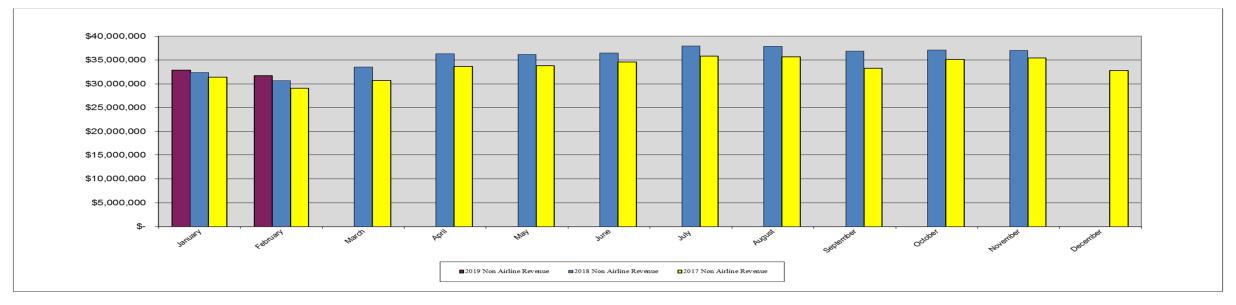

Metropolitan Washington Airports Authority Financial Statements February 2019 Aviation Enterprise Fund – Highlights in Brief

- ✤ Total operating revenues for the Aviation Enterprise Fund for February 2019 were \$63.2 million. Operating revenues increased from January 2019 by \$2.7 million mostly due to increases in rents of \$3.3 million, landing fees of \$1.0 million and passenger conveyance fees of \$0.1 million offset by decreases in concessions of \$1.3 million, utility sales of \$0.3 million and international arrival fees of \$0.2 million.
- → Operating revenues of \$123.7 million through February 2019 were an increase of \$3.3 million from 2018 totals primarily due to increases in landing fees of \$1.7 million, concessions of \$1.5 million and rents of \$1.2 million offset by decreases in international arrival fees of \$0.5 million, passenger conveyance fees of \$0.3 million and other revenues of \$0.2 million.
- ✤ Total operating expenses for the Aviation Enterprise Fund during the month of February 2019 were \$51.0 million, which is \$7.9 million lower than January 2019 mostly due to decreases in salaries and related benefits of \$6.9 million, materials and supplies of \$1.5 million, utilities of \$0.2 million and project expenses of \$0.1 million offset by increases in depreciation and amortization of \$0.4 million, services of \$0.3 million and telecommunications of \$0.1 million.
- → Operating expenses of \$109.8 million through February 2019 were \$7.6 million higher than 2018 primarily due to increases in services of \$4.7 million, salaries and related benefits of \$1.8 million, depreciation and amortization of \$0.9 million, telecommunications of \$0.3 million, utilities of \$0.1 million and insurance of \$0.1 million offset by a decrease in project expenses of \$0.2 million.
- → Operating income for the Aviation Enterprise Fund in February 2019 was \$12.2 million compared to operating income of \$1.6 million in January 2019.
- → Year-to-date through February 2019, operating income was \$13.8 million compared to operating income of \$18.1 million as of February 2018.

- → In February 2019 there were net non-operating expenses of \$8.2 million compared to net non-operating expenses in January 2019 of \$13.9 million. The difference of \$5.7 million was due to increases in the fair value gain on swaps of \$7.4 million and federal, state, and local grants of \$0.2 million offset by decreases in investment gain of \$1.9 million and interest expenses of \$0.1 million.
- Net non-operating expenses through February 2019 were \$22.1 million. The difference of \$24.6 million were primarily due to decreases in fair value gain on swaps of \$24.7 million, federal, state and local grants of \$4.1 million offset by increases in investment gains of \$5.7 million and interest expense of \$1.5 million
- → The net capital contributions for the Aviation Enterprise Fund for the month of February 2019 were 6.6 million compared to \$6.3 million in January 2019. The \$0.3 million increases were due to an increase in passenger facility charges of \$0.4 million offset by decreases in federal, state and local grants of \$0.8 million and net contributions to other governments of \$0.7 million. Year-to-date capital contributions were \$12.9 million, an increase of \$1.8 million from 2018 due to decreases in net contributions to other governments of \$2.1 million and passenger facility charges of \$1.2 million offset by an increase in federal, state and local grants of \$0.9 million.
- ✤ There was an increase in net position for the Aviation Enterprise Fund for the month of February 2019 of \$10.6 million compared to a decrease of \$5.9 million for the prior month.
- → The year-to-date increase in net position through February 2019 was \$4.7 million compared to a year-to-date increase of \$31.7 million through February 2018.
- → Debt service coverage increased from 1.54x from January 2019 to 1.71x for February 2019.

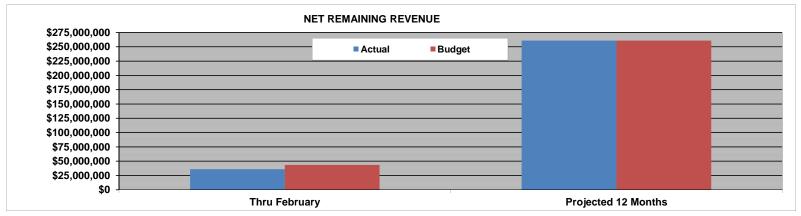
