



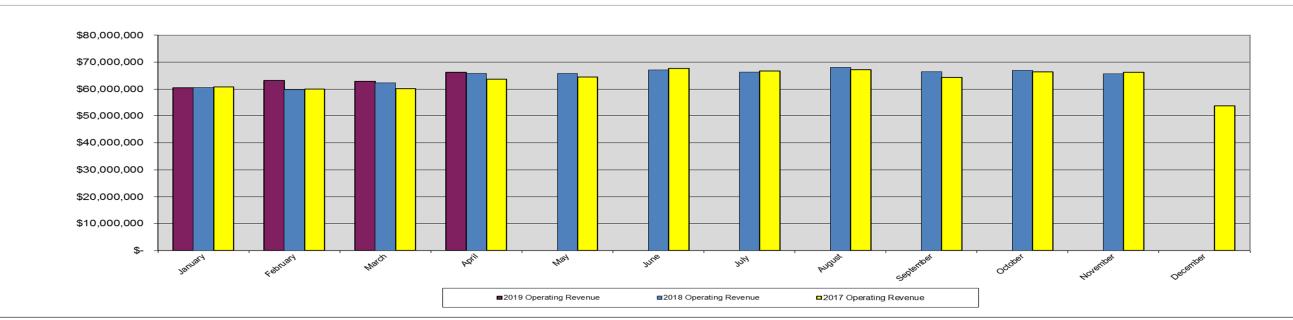

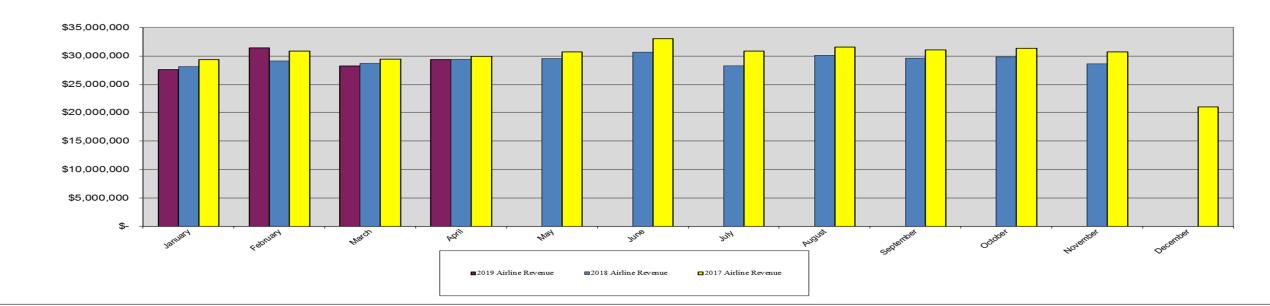
Total Revenue

- Total Revenue thru April 2019 is 0.9% higher than forecast



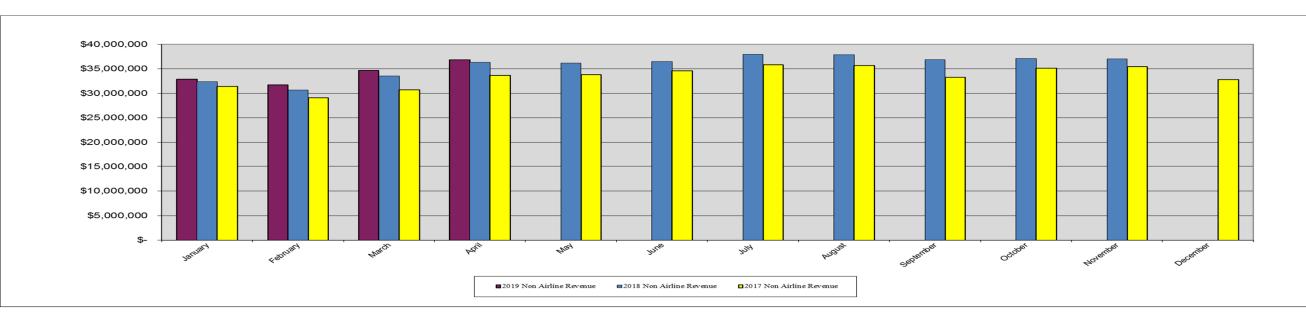
<u>Airline Revenue</u>

- Aviation Enterprise Fund Highlights in Brief
- Total operating revenues for the Aviation Enterprise Fund for April 2019 were \$66.3 million. Operating revenues increased from March 2019 by \$3.4 million mostly due to increases in concessions of \$3.5 million, landing fees of \$0.2 million, international arrival fees of \$0.3 million and utility sales of \$0.1 million offset by decreases in rents of \$0.1 million and other revenues of \$0.7 million.
- Operating revenues of \$252.8 million through April 2019 were an increase of \$4.4 million from 2018 totals primarily due to increases in concessions of \$2.6 million, landing fees of \$2.8 million, rents of \$0.9 million and other revenues of \$0.2 million offset by decreases in utility sales of 0.2 million, international arrival fees of \$1.2 million, and passenger conveyance fees of \$0.7 million.
- Total operating expenses for the Aviation Enterprise Fund during the month of April 2019 were \$52.3 million, which is \$1.2 million lower than March 2019 mostly due to decreases in services of \$0.5 million, materials and supplies of \$1.4 million, utilities of \$0.2 million, telecommunications of \$0.1 million and non-cash expenses of 0.1 million offset by increases in salaries and related benefits of \$0.4 million, project expenses of \$0.3 million, and depreciation and amortization of \$0.4 million.
- Operating expenses of \$215.6 million through April 2019 were \$5.2 million higher than 2018 primarily due to increases in services of \$4.3 million, salaries and related benefits of \$1.2 million, lease from U.S. government of \$0.1 million, utilities of \$0.2 million, insurance of \$0.2 million and project expenses of \$0.2 million offset by decreases in materials and supplies of \$0.8 million and depreciation and amortization of \$0.1 million.
- → Operating income for the Aviation Enterprise Fund in April 2019 was \$14.0 million compared to operating income of \$9.4 million in March 2019.
- Year-to-date through April 2019, operating income was \$37.2 million compared to operating income of \$38.0 million as of April 2018.

- In April 2019 there were net non-operating expenses of \$5.8 million compared to net non-operating expenses in March 2019 of \$19.7 million. The difference of \$14.0 million was due to increases in the fair value gain on swaps of \$16.8 million offset by a decrease in investment gains of \$1.4 million and an increase in interest expenses of \$1.5 million.
- Net non-operating expenses through April 2019 were \$47.6 million. The difference of \$37.2 million was primarily due to increases in fair value loss on swaps of \$36.9 million, an increase in interest expense of \$2.9 million, a decrease in federal, state and local grants of \$8.4 million offset by an increase in investment gains of \$11.0 million.
- The net capital contributions for the Aviation Enterprise Fund for the month of April 2019 were \$8.3 million compared to \$7.4 million in March 2019. The \$0.9 million increase was due to an increase in federal, state and local grants of \$0.5 million and a decrease in net contributions from (to) other governments of \$1.5 million offset by a decrease in passenger facility charges of \$1.1 million.
- Year-to-date capital contributions were \$28.6 million, an increase of \$0.8 million from 2018 due to an increase in net contributions to other governments of \$2.1 million offset by increases in passenger facility charges of \$1.2 million and federal, state, and local grants of \$1.6 million.
- There was an increase in net position for the Aviation Enterprise Fund for the month of April 2019 of \$16.5 million compared to a decrease of \$3.0 million for the prior month.
- The year-to-date increase in net position through April 2019 was \$18.2 million compared to a year-to-date increase of \$55.4 million through April 2018.
- → Debt service coverage increased from 1.76x from March 2019 to 1.84x for April 2019.

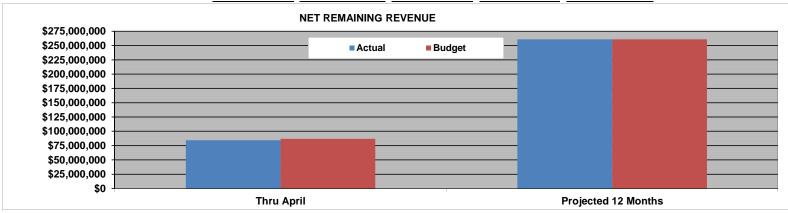
