

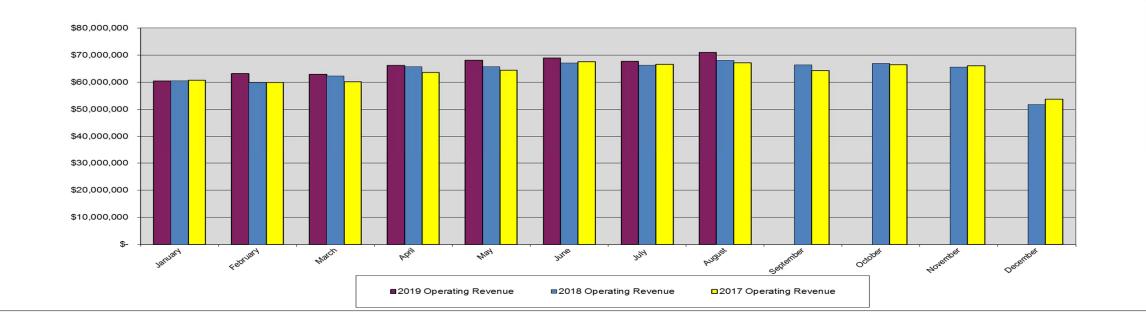

Total Revenue

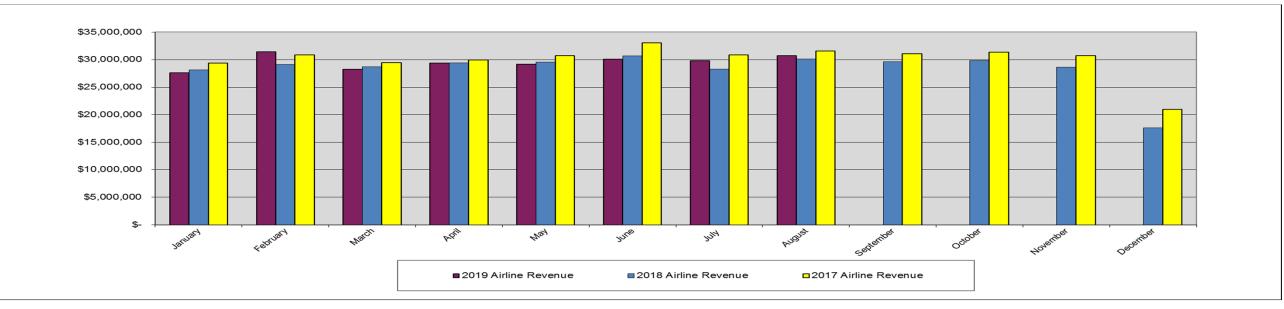
- Total Revenue thru August 2019 is \$528.6 million

<u>Airline Revenue</u>

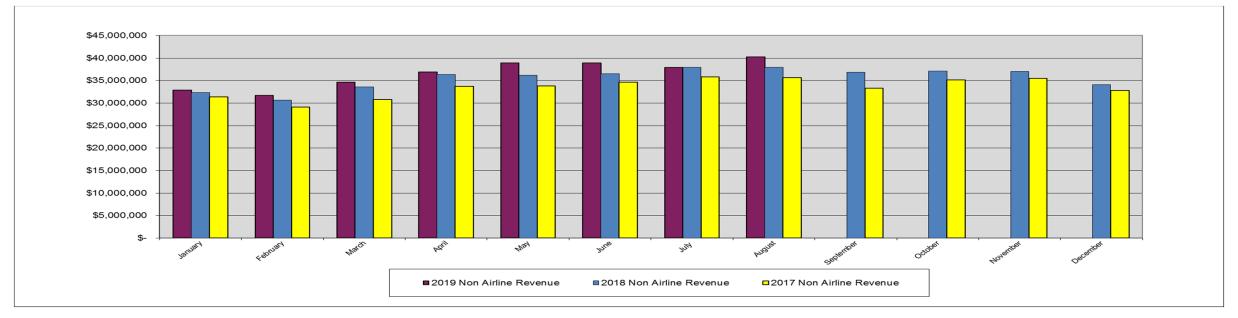
- Airline Revenue thru August 2019 is \$236.4 million

Metropolitan Washington Airports Authority Financial Statements August 2019 Aviation Enterprise Fund – Highlights in Brief

- ✤ Total operating revenues for the Aviation Enterprise Fund for August 2019 were \$71.0 million. Operating revenues increased from July 2019 by \$3.3 million mostly due to increases in concessions of \$2.1 million, rents of \$0.4 million, international arrival fees of \$0.4 million, other revenues of \$0.2 million, landing fees of \$0.1 million and utility sales of \$0.1 million.
- → Operating revenues of \$528.6 million through August 2019 were an increase of \$12.9 million from 2018 totals primarily due to increases in concessions of \$9.4 million, landing fees of \$5.6 million and rents of \$1.0 million offset by decreases in passenger conveyance fees of \$1.5 million, international arrival fees of \$1.1 million, other revenues of \$0.3 million and utility sales of \$0.1 million.
- ★ Total operating expenses for the Aviation Enterprise Fund during the month of August 2019 were \$55.4 million, which is \$2.6 million lower than July 2019 mostly due to decreases in salaries and related benefits of \$1.5 million, services of \$1.3 million, project expenses of \$0.5 million, insurance of \$0.2 million, depreciation and amortization of \$0.2 million and telecommunications of \$0.1 million offset by an increase in materials and supplies of \$1.1 million.
- → Operating expenses of \$433.6 million through August 2019 were \$6.3 million higher than 2018 primarily due to increases in services of \$4.9 million, materials and supplies of \$2.7 million, salaries and related benefits of \$1.9 million, insurance of \$0.9 million, telecommunications of \$0.5 million, utilities of \$0.5 million, project expenses of \$0.3 million, travel of \$0.1 million, non-cash expenses of \$0.1 million and the lease from the U.S. government of \$0.1 million offset by a decrease in depreciation and amortization of \$5.6 million.
- → Operating income for the Aviation Enterprise Fund in August 2019 was \$15.6 million compared to operating income of \$9.6 million in July 2019.
- → Year-to-date through August 2019, operating income was \$95.0 million compared to operating income of \$88.4 million as of August 2018.

- ➤ In August 2019 there were net non-operating expenses of \$35.8 million compared to net non-operating expenses in July 2019 of \$10.3 million. The difference of \$25.5 million was due to increases in the fair value loss on swaps of \$24.6 million and interest expense of \$1.7 million offset by an increase in investment gain of \$0.9 million.
- → Net non-operating expenses through August 2019 were \$134.0 million. The difference of \$92.6 million was primarily due to increases in fair value loss on swaps of \$88.1 million, a decrease in federal, state and local grants of \$16.5 million and an increase in interest expense of \$7.6 million offset by an increase in investment gain of \$19.5 million.
- → The net capital contributions for the Aviation Enterprise Fund for the month of August 2019 were \$6.0 million compared to \$7.0 million in July 2019. The \$1.1 million decrease was due to a decrease in passenger facility charges of \$1.2 million and an increase of net contributions to other governments of \$0.4 million offset by an increase in federal, state and local grants of \$0.5 million.
- Year-to-date capital contributions were \$57.8 million, a decrease of \$1.1 million from 2018 due to decreases in passenger facility charges of \$3.5 million and federal, state, and local grants of \$1.1 million offset by a decrease in net contributions to other governments of \$3.5 million.
- → There was a decrease in net position for the Aviation Enterprise Fund for the month of August 2019 of \$14.3 million compared to an increase of \$6.4 million for the prior month.
- → The year-to-date increase in net position through August 2019 was \$18.8 million compared to a year-to-date increase of \$106.0 million through August 2018.
- → Debt service coverage increased from 1.98x from July 2019 to 2.02x for August 2019.
