



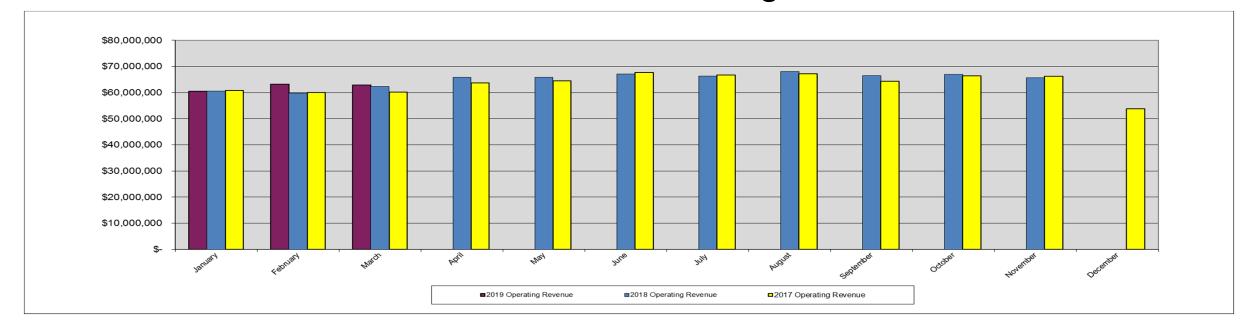

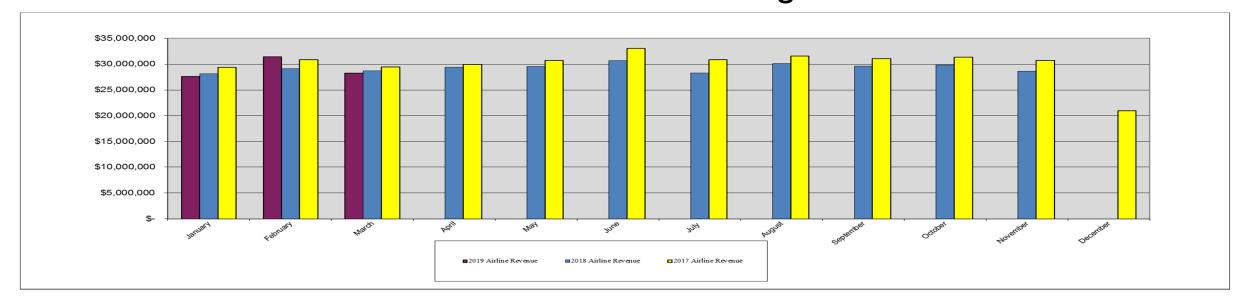
Total Revenue

- Total Revenue thru March 2019 is 0.9% higher than forecast



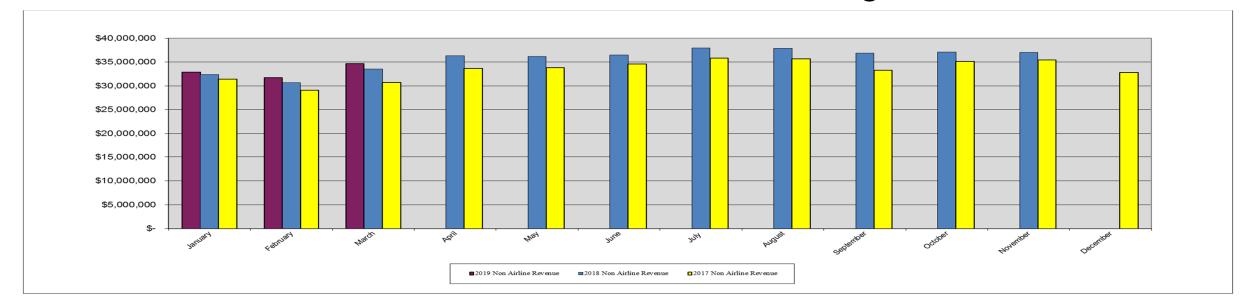
Airline Revenue

Metropolitan Washington Airports Authority Financial Statements March 2019 Aviation Enterprise Fund – Highlights in Brief

- Total operating revenues for the Aviation Enterprise Fund for March 2019 were \$62.9 million. Operating revenues decreased from February 2019 by \$0.3 million mostly due to decreases in rents of \$2.1 million, landing fees of \$0.3 million, international arrival fees of \$0.2 million, passenger conveyance fees of \$0.1 million and utility sales of \$0.1 million offset by increases in concessions of \$1.9 million and other revenues of \$0.6 million.
- Operating revenues of \$186.6 million through March 2019 were an increase of \$4.0 million from 2018 totals primarily due to increases in landing fees of \$2.4 million, concessions of \$1.7 million, rents of \$1.1 million and other revenues of \$0.4 million offset by decreases in international arrival fees of \$0.8 million, passenger conveyance fees of \$0.5 million and utility sales of \$0.3 million.
- Total operating expenses for the Aviation Enterprise Fund during the month of March 2019 were \$53.5 million, which is \$2.5 million higher than February 2019 mostly due to increases in salaries and related benefits of \$2.1 million, materials and supplies of \$1.2 million, project expenses of \$0.3 million, telecommunications of \$0.1 million and non-cash expenses of \$0.1 million offset by decreases in depreciation and amortization of \$0.9 million, services of \$0.3 million and insurance of \$0.1 million.
- Operating expenses of \$163.3 million through March 2019 were \$4.4 million higher than 2018 primarily due to increases in services of \$4.0 million, salaries and related benefits of \$0.5 million, utilities of \$0.4 million, telecommunications of \$0.3 million and insurance of \$0.2 million offset by decreases in materials and supplies of \$0.5 million, depreciation and amortization of \$0.3 million and project expenses of \$0.2 million.
- Operating income for the Aviation Enterprise Fund in March 2019 was \$9.4 million compared to operating income of \$12.2 million in February 2019.
- Year-to-date through March 2019, operating income was \$23.2 million compared to operating income of \$23.7 million as of March 2018.

- In March 2019 there were net non-operating expenses of \$19.7 million compared to net non-operating expenses in February 2019 of \$8.2 million. The difference of \$11.5 million was due to increases in the fair value loss on swaps of \$15.1 million, a decrease in federal, state, and local grants of \$0.2 million offset by an increase in investment gains of \$2.4 million and a decrease in interest expenses of \$1.4 million.
- Net non-operating expenses through March 2019 were \$41.8 million. The difference of \$32.5 million was primarily due to increases in fair value loss on swaps of \$33.0 million, an increase in interest expense of \$1.8 million, a decrease in federal, state and local grants of \$6.1 million offset by an increase in investment gains of \$8.4 million.
- The net capital contributions for the Aviation Enterprise Fund for the month of March 2019 were \$7.4 million compared to \$6.6 million in February 2019. The \$0.8 million increase was due to increases in passenger facility charges of \$2.0 million and federal, state and local grants of \$0.2 million offset by an increase in net contributions to other governments of \$1.4 million. Year-to-date capital contributions were \$20.3 million, an increase of \$2.7 million from 2018 due to decreases in net contributions to other governments of \$1.7 million, an increase in federal, state, and local grants of \$1.2 million offset by a decrease in passenger facility charges of \$0.2 million.
- There was a decrease in net position for the Aviation Enterprise Fund for the month of March 2019 of \$3.0 million compared to an increase of \$10.6 million for the prior month.
- The year-to-date increase in net position through March 2019 was \$1.7 million compared to a year-to-date increase of \$31.9 million through March 2018.
- → Debt service coverage increased from 1.71x from February 2019 to 1.76x for March 2019.

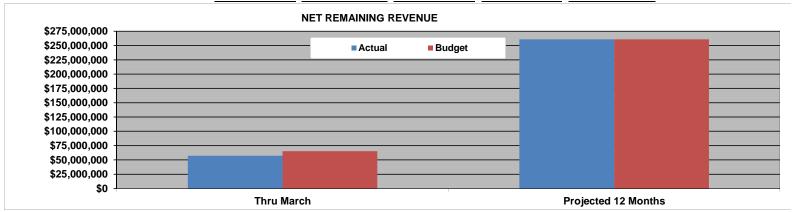
