



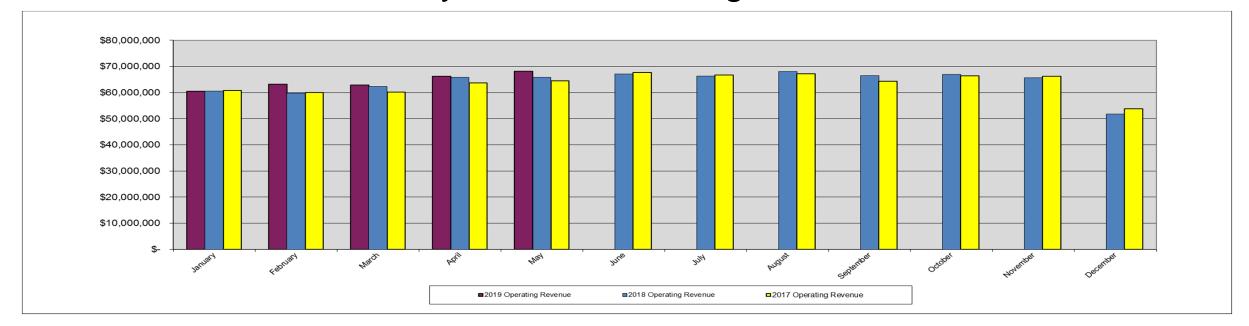

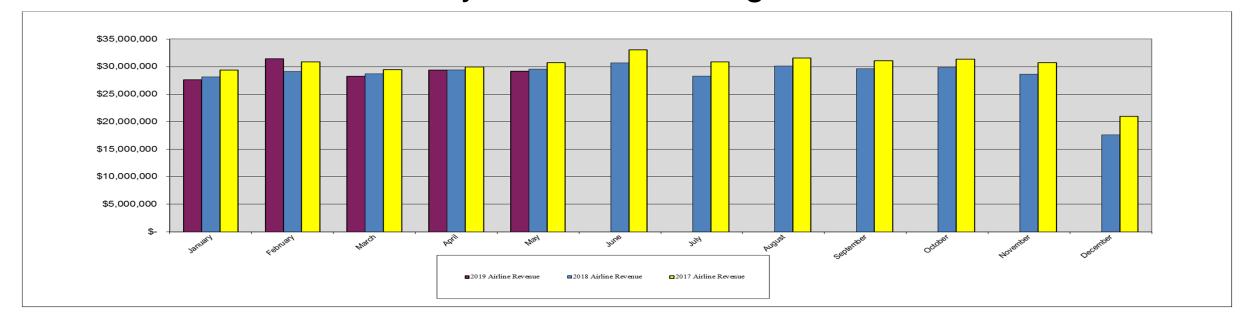
### Total Revenue

- Total Revenue thru May 2019 is 1.1% higher than forecast



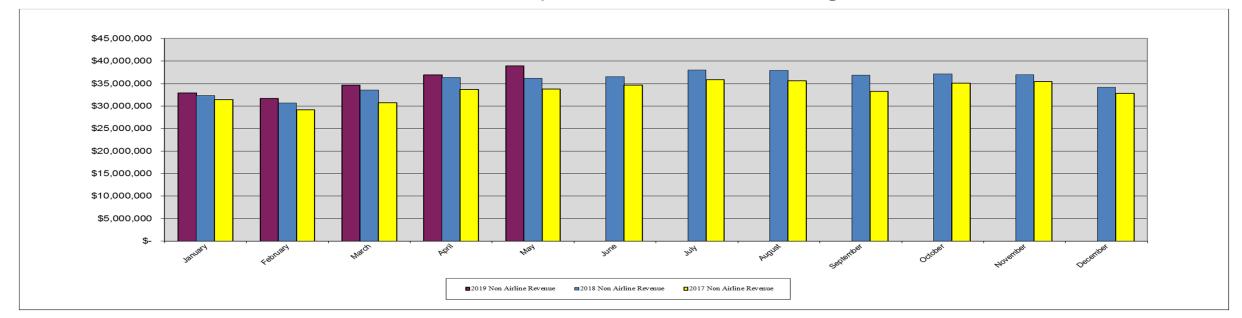
## <u>Airline Revenue</u>

#### Aviation Enterprise Fund – Highlights in Brief

- Total operating revenues for the Aviation Enterprise Fund for May 2019 were \$68.1 million. Operating revenues increased from April 2019 by \$1.8 million mostly due to increases in concessions of \$1.3 million, rents of \$0.5 million and international arrival fees of \$0.2 million offset by a decrease in utility sales of \$0.2 million.
- Operating revenues of \$320.9 million through May 2019 were an increase of \$6.8 million from 2018 totals primarily due to increases in concessions of \$4.9 million, landing fees of \$3.3 million and rents of \$1.4 million offset by decreases in international arrival fees of \$1.3 million, passenger conveyance fees of \$0.9 million and utility sales of \$0.6 million.
- Total operating expenses for the Aviation Enterprise Fund during the month of May 2019 were \$54.8 million, which is \$2.5 million higher than April 2019 mostly due to increases in salaries and related benefits of \$1.2 million, services of \$0.6 million, depreciation and amortization of \$0.5 million, telecommunications of \$0.4 million, materials and supplies of \$0.1 million and non-cash expenses of \$0.1 million offset by decreases in project expenses of \$0.1 million and utilities of \$0.1 million.
- Operating expenses of \$270.5 million through May 2019 were \$0.1 million lower than 2018 primarily due to decreases in depreciation and amortization of \$7.4 million and materials and supplies of \$0.5 million offset by increases in services of \$5.1 million, salaries and related benefits of \$1.4 million, insurance of \$0.4 million, telecommunications of \$0.4 million, utilities of \$0.3 million, project expenses of \$0.1 million, lease from U.S. government of \$0.1 million and travel of \$0.1 million.
- Operating income for the Aviation Enterprise Fund in May 2019 was \$13.3 million compared to operating income of \$14.0 million in April 2019.
- Year-to-date through May 2019, operating income was \$50.5 million compared to operating income of \$43.6 million as of May 2018.

- In May 2019 there were net non-operating expenses of \$25.7 million compared to net non-operating expenses in April 2019 of \$5.8 million. The difference of \$19.9 million was due to increases in the fair value loss on swaps of \$21.4 million and interest expense of \$0.1 million offset by increases in investment gains of \$1.3 million and federal, state and local grants of \$0.3 million.
- Net non-operating expenses through May 2019 were \$73.3 million. The difference of \$50.1 million was primarily due to increases in fair value loss on swaps of \$49.7 million, an increase in interest expense of \$3.4 million, a decrease in federal, state and local grants of \$10.3 million offset by an increase in investment gain of \$13.3 million.
- The net capital contributions for the Aviation Enterprise Fund for the month of May 2019 were \$8.1 million compared to \$8.3 million in April 2019. The \$0.2 million decrease was due to an increase in net contributions to other governments of \$0.5 million and a decrease in passenger facility charges of \$0.1 million offset by an increase in federal, state and local grants of \$0.4 million.
- Year-to-date capital contributions were \$36.6 million, an increase of \$4.6 million from 2018 due to a decrease in net contributions to other governments of \$3.9 million and an increase in passenger facility charges of \$0.8 million offset by a decrease in federal, state, and local grants of \$0.1 million.
- There was a decrease in net position for the Aviation Enterprise Fund for the month of May 2019 of \$4.4 million compared to an increase of \$16.5 million for the prior month.
- The year-to-date increase in net position through May 2019 was \$13.8 million compared to a year-to-date increase of \$52.5 million through May 2018.
- → Debt service coverage increased from 1.84x from April 2019 to 1.87x for May 2019.

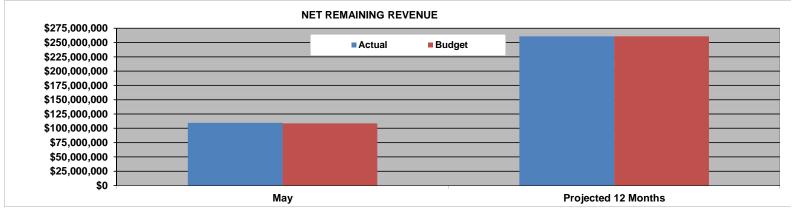
