


Total Revenue

Metropolitan Washington Airports Authority Financial Statements May 2017 Aviation Enterprise Fund – Highlights in Brief

- → Total operating revenues for the Aviation Enterprise Fund for May 2017 were \$64.5 million. Operating revenues increased from April 2017 by \$0.9 million mostly due to increases in landing fees of \$0.8 million, concessions of \$0.3 million and international arrival fees of \$0.1 million offset by decreases in utility sales of \$0.2 million and rents of \$0.1 million.
- → Operating revenues of \$309.2 million through May 2017 were a decrease of \$6.8 million from 2016 totals. Rents decreased by \$8.8 million, landing fees by \$3.1 million, international arrival fees by \$1.4 million, passenger conveyance fees by \$0.5 million and utility sales by \$0.1 million offset by increases in concessions of \$6.9 million and other revenues of \$0.3 million.
- ✤ Total operating expenses for the Aviation Enterprise Fund during the month of May 2017 were \$52.9 million, which is \$5.3 million higher than April 2017 mostly due to increases in services of \$3.0 million, salaries and related benefits of \$2.6 million and materials and supplies of \$0.4 million offset by decreases in telecommunications of \$0.3 million, utilities of \$0.2 million, insurance of \$0.1 million and project expenses of \$0.1 million.
- → Operating expenses of \$255.5 million through May 2017 were \$5.5 million lower than 2016 primarily due to decreases in depreciation and amortization of \$5.9 million, insurance of \$0.5 million and utilities of \$0.3 million offset by increases in salaries and related benefits of \$1.5 million, telecommunications of \$0.7 million, materials and supplies of \$0.6 million, services of \$0.5 million and project expenses of \$0.2 million.
- ✤ Operating income for the Aviation Enterprise Fund in May 2017 was \$11.6 million compared to operating income of \$16.1 million in April 2017.
- ✤ Year-to-date through May 2017, operating income was \$53.7 million compared to operating income of \$57.2 million as of May 2016.
- → In May 2017 there were net non-operating expenses of \$15.2 million compared to net non-operating expenses in April 2017 of \$15.0 million. The difference of \$0.2 million is primarily due to an increase of \$0.1 million change in the swaps fair value offset by a decrease to federal, state and local grants of \$0.1 million, an investment loss of \$0.1 million and an increase in interest expenses of \$0.1 million.

- → Net non-operating expenses through May 2017 were \$56.6 million. The positive difference from prior year-to-date of \$36.4 million is mostly comprised of a \$20.0 million gain in swaps fair value, an increase to federal, state and local grants of \$10.3 million, a \$5.7 million decrease in interest expense and an increase of \$0.5 million in investment gains.
- The net capital contributions for the Aviation Enterprise Fund for the month of May 2017 were a negative \$2.7 million compared to a positive \$13.6 million in April 2017. The \$16.3 million decrease is due to a decrease in other capital property contributed of \$15.5 million, a decrease in passenger facility charges of \$0.7 million and a decrease infeceral, state and local grants of \$0.2 million. Year-to-date capital contributions were \$21.2 million, a decrease of \$9.0 million from 2016 due to decreases of \$8.8 million in other capital property contributed and federal, state and nocal grants of \$1.2 million offset by increases of \$1.0 million in passenger facility charges.
- There is an decrease in net position for the Aviation Enterprise Fund for the month of May 2017 of \$6.3 million compared to a increase of \$14.7 million for the prior month.
- → The year-to-date increase in net position through May 2017 was \$18.2 million compared to a year-to-date decrease of \$5.7 through May 2016.
- Accounts receivables delinquent over 30 days, including amounts past due which are in bankruptcy proceedings, had a balance of \$3.9 million as of May 31, 2017, an increase of 16.7% from April 30, 2017. Delinquent accounts receivables for customer accounts which have a net credit balance are excluded from reported delinquent receivables.
- → Debt service coverage increased from 1.73x from April 2017 to 1.74x for May 2017.


